



RAVENNA EUROPEAN CUP 2016

RULES – UNDER 15 CATEGORY

ART. 1: ORGANISATION THE "FUTURE CHAMPIONS" CLUB ANNOUNCES AND ORGANISES AN INTERNATIONAL TOURNAMENT, THE **RAVENNA EUROPEAN CUP 2016**, WHICH WILL BE HELD **FROM MAY 5TH TO MAY 8TH, 2016** IN THE FOLLOWING SPORTS CENTRES:

VIA ABBADIA 4, SAN PIETRO IN VINCOLI (RA) – VIA CLASSESE 120, CLASSE (RA) – VIA TAMIGI 11, SAVIO (RA) – PIAZZA FORLIMPOPOLI, LIDO DI SAVIO (RA) – VIA ROMEA SUD, FOSSO GHIAIA (RA) – VIA VICOLO DELLA VECCHIA 2, SAN ZACCARIA (RA) – VIA ROMEA 122, RAVENNA (RA) – VIA ANCONA, RAVENNA (RA)

ART. 2: ATTENDANCE CATEGORY AND AGE LIMITS THE TOURNAMENT IS STRICTLY RESERVED TO PLAYERS BELONGING TO THE **UNDER 15** CATEGORY WHO MUST BE REGULAR MEMBERS OF THEIR CLUB AND FEDERATION IN THE CURRENT SEASON, BORN SINCE JANUARY 1ST, 2001 AT THE AGE OF TWELVE.

ART. 3: LOANS LOANS ARE ALLOWED FOR A MAXIMUM OF 3 (THREE) PLAYERS PER TEAM. THESE LOANS ARE NOT INTERCHANGEABLE AND ARE EFFECTIVE FOR THE WHOLE DURATION OF THE TOURNAMENT, UPON PRESENTATION OF LEGAL AUTHORISATION ISSUED BY THE RELEVANT CLUB, WHICH MUST NOT COMPETE IN THE TOURNAMENT.

ART. 4: PLAYERS' LISTS PRIOR TO THE START OF THE TOURNAMENT THE COMPETING CLUBS MUST SUBMIT A LIST WITH THE NAMES OF THE INTENDED PLAYERS, UP TO A MAXIMUM OF 24. IT IS FORBIDDEN TO ALTER THESE LISTS AFTER THEY HAVE BEEN SUBMITTED. PRIOR TO THE TOURNAMENT A LIST WITH A MAXIMUM OF 18 PLAYERS MUST BE PRESENTED TO THE REFEREE.

ART. 5: SUBSTITUTIONS: UP TO 7 SUBSTITUTIONS ARE ALLOWED, INDEPENDENTLY FROM THE PLAYER'S ROLE, AT ANY TIME DURING THE TOURNAMENT.

ART. 6: COMPETING CLUBS THE FOLLOWING CLUBS WILL BE COMPETING IN THE TOURNAMENT: SEE THE CALENDAR OF MATCHES

ART 7: FORMULA OF THE TOURNAMENT THE TOURNAMENT WILL BE ORGANISED AS FOLLOWS :

Seven rounds of 6 teams will be formed and they will compete with one way competitions. At the end of each heat the first two of each heat and the two best third in ranking will enter the elimination stage, in total 16 teams which will form the qualifying heats, followed by the quarter-finals, semi-finals and final.

ART. 8: RANKINGS THE RANKINGS WILL BE IN COMPLIANCE WITH THE FOLLOWING CRITERIA: 3 POINTS IN CASE OF VICTORY - 1 POINT IN CASE OF DRAW - 0 POINTS IN CASE OF DEFEAT.

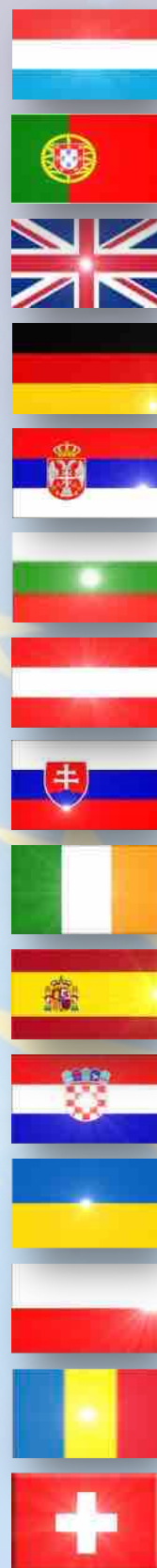
IN CASE OF SCORE DRAW, THE FOLLOWING CRITERIA WILL APPLY:

1. OUTCOME OF DIRECT COMPETITIONS
2. GOALS DIFFERENCE IN DIRECT COMPETITIONS OF TEAMS WITH DRAW SCORES.
3. GOALS DIFFERENCE ON THE TOTAL NUMBER OF COMPETITIONS PLAYED IN THAT ROUND
4. MAJORITY OF GOALS ON THE TOTAL NUMBER OF COMPETITIONS PLAYED IN THAT ROUND
5. DRAWING

ART. 9: COMPETITION TIMES THE COMPETITIONS WILL BE HELD IN 2 (TWO) FULL TIMES OF 20 MINUTES EACH.

THE TEAMS MUST COMPETE WITH 11 PLAYERS ON THE FIELD.

THE MATCHES WILL BE PLAYED ON STANDARD-SIZED FOOTBALL PITCHES WITH STANDARD-SIZED GOALS, WITH BALLS SIZE 5.

ART. 10: PENALTY SHOOTOUTS PENALTY SHOOTOUTS APPLY TO FINALS, SEMI-FINALS OR KNOCKOUT STAGE MATCHES. IN CASE OF DRAW AT THE END OF THE TWO FULL TIMES, PENALTY SHOOTOUTS WILL DECIDE ON THE WINNER, IN COMPLIANCE WITH THE PROCEDURES SET OUT IN RULE NO. 7 OF THE GAME REGULATIONS AND OFFICIAL DECISIONS;

ART. 11: EXTRA TIMES EXTRA TIMES ONLY APPLY TO THE FINAL FOR FIRST AND SECOND PLACE: IN CASE OF DRAW, TWO EXTRA TIMES OF 10 MINUTES EACH WILL BE PLAYED AT THE END OF THE FULL TIMES. IN CASE OF GAME TIED AT THE END OF THE TWO EXTRA TIMES, PENALTY SHOOTOUTS WILL DECIDE ON THE WINNER, AS PER ART.10

ART. 12: REFEREES COMPETITIONS WILL BE OFFICIATED BY F.I.G.C./ A.I.A. REFEREES,

ART. 13: TOURNAMENT COMMITTEE A TOURNAMENT COMMITTEE WILL BE ARRANGED AND WILL BE IN CHARGE FOR ANY ARGUMENT, OBJECTION, COMPLAINT OR UNFORESEEN EVENT. THE COMMITTEE WILL CONSIST OF THE FOLLOWING PEOPLE:

THE COMMITTEE WILL NOT ACCEPT OBJECTIONS OR COMPLAINTS ON THE DECISIONS TAKEN BY THE REFEREES.

THE COMMITTEE WILL INFORM THEIR NATIONAL OR INTERNATIONAL FEDERATION IN CHARGE OF TAKING MEASURES AGAINST ANY PLAYERS FOUND GUILTY OF UNSPORTSMANLIKE BEHAVIOUR THROUGHOUT THE DURATION OF THE TOURNAMENT

ART. 14: TOURNAMENT DISCIPLINE THE TOURNAMENT DISCIPLINE WILL BE TAKEN IN CHARGE BY THE OFFICIAL SPORTS JUDGE OR BY THE SUBSTITUTE OF THE COMMITTEE OF COMPETENCE

ART. 15: PENALTIES AUTOMATISM (IN QUICK TOURNAMENTS) THERE WILL BE A PENALTY AUTOMATISM IN COMPLIANCE WITH THE FOLLOWING PROCEDURES: A RED-CARDED PLAYER CANNOT COMPETE IN HIS NEXT GAME, EXCEPT FOR GREATER PENALTIES INFLICTED BY THE SPORTS JUDGE; A PLAYER WHO, THROUGHOUT THE TOURNAMENT RECEIVES TWO YELLOW CARDS WILL BE DISQUALIFIED FOR ONE MATCH AS DECLARED BY THE SPORTS JUDGE.

ART. 16: COMPLAINTS ANY COMPLAINTS MUST BE PRESENTED WITHIN 30 MINUTES FROM THE END OF THE MATCH AND MUST BE ACCOMPANIED BY A €40,00 TAX; A COPY OF THE COMPLAINT MUST BE DELIVERED TO THE COUNTERPARTY WITHIN 30 MINUTES.

ART. 17: INSURANCE EACH COMPETING CLUB IS RESPONSIBLE OF PROVIDING THEIR PLAYERS WITH AN INSURANCE. THE ORGANISATION OF THE TOURNAMENT IS RESPONSIBLE FOR THE REGULARITY OF SAID INSURANCE.

ART. 18: I.F.A.B.THE MATCHES WILL BE PLAYED IN COMPLIANCE WITH THE INTERNATIONAL FOOTBALL ASSOCIATIONS BOARD (IFAB), CURRENT EDITION.

ART. 19: GENERAL REGULATIONS UNLESS OTHERWISE PROVIDED FOR IN THESE REGULATIONS, THE STATUTORY LAWS SHALL APPLY IF COMPATIBLE, AS WELL AS THOSE ON THE NO.1 OFFICIAL PUBLIC STATEMENT OF THE SCHOOL SECTOR RELATED TO THE CURRENT SPORTS SEASON.
